Submissions are first reviewed by the Submissions Committee and then externally assessed on a double-blind basis before a decision is made on acceptance.

Manuscripts should be sent by email to the address above, to the attention of the Managing Editors of Submissions. Authors will be asked to confirm that their manuscripts have not been submitted elsewhere. Manuscripts should generally not be longer than 10,000 words excluding footnotes. Manuscripts longer than 15,000 words including footnotes will not be accepted. Articles must be submitted in Word, with at least 12-point font being used for text and a 10-point font for footnotes. Footnotes rather than endnotes should be used, and footnotes must conform to the *Canadian Guide to Uniform Legal Citation*, 9th Edition. The *Queen's Law Journal* formats the body of the text in accordance with the *Canadian Guide to Legal Style*, 2nd Edition.
